DESCRIPTION:	Performs a variety of professional nursing and routine medical services which are directly related to patient care of inmates legally in the custody of the Columbia County Detention Facility, including independent judgment in assessment, treatment of illnesses and minor wounds and follow-up nursing care as directed.
DUTIES:	<ul> <li>Provide medical care to inmates in the facility in accordance with recognized nursing techniques and procedures, physician's orders, agency policy and FMJS requirements.</li> <li>Provide emergency first aid.</li> <li>Prepares and schedules sick call and arranges appointments for inmates with doctors.</li> <li>Observe, recognize and interpret symptoms of patient's conditions and record observations.</li> <li>Check inmate vital signs and keep appropriate records.</li> <li>Application of dressing and bandages.</li> <li>Interview incoming inmates to acquire a health history.</li> <li>Dispense medication and other medical treatment.</li> <li>Maintain security and safety aspects regarding inmate medical services.</li> <li>Prepare necessary records and reports.</li> <li>Assist the facility physician in administering medical practices.</li> <li>Inventory over the counter medications for efficient amount stored.</li> <li>Screen medical charts, to include vault for excess or no longer used medications and prepare the proper forms for destroying such.</li> <li>Coordinate all outgoing correspondence, to include ordering supplies, with the Medical Supervisor.</li> <li>Supports Sheriff's Office Strategic Plan</li> <li>Be on after hours on-call on a rotating basis</li> </ul>
